**Acute Health Effects:** Irritating to the skin and eyes on contact. Inhalation will cause irritation to the lungs and mucus membrane. Irritation to the eyes will cause watering and redness. The degree of combustibility in air is dependent upon particle size, oxide coating, and quality of dispersion. The hazard increases with particle fineness. Avoid generating sparks or ignition sources in areas of high airborne dust levels or in areas with accumulated dust. Thoroughly clean areas or equipment to be maintained prior to dust disturbing or ignition source generation activities.
